**RESOLUTION 01-2024**

**ADOPTING THE 2024 AMENDMENT TO THE CLERMONT  
COUNTY COMPREHENSIVE PLAN, PER OHIO REVISED  
CODE SECTION 713.23**

**WHEREAS**, the Planning Commission recognizes the importance of planning for the future growth and development of Clermont County, Ohio; and,

**WHEREAS**, the Planning Commission developed the Clermont County Comprehensive Plan as a guide to assist townships, developers and community leaders in making good decisions regarding future development; and

**WHEREAS**, the current Comprehensive Plan was adopted by the Planning Commission on April 22, 2014; and

**WHEREAS**, the Comprehensive Plan Transportation section details the Current and Future Transportation Projects that were in planned in 2014, many of which have been completed subsequent to the adoption of the plan; and

**WHEREAS**, the Clermont County Engineer is recommending the adoption of the 2024 Amendment to the Transportation Section that updates the Current and Future Transportation Projects; and


